Q: What is TUPAD?

A: The Tulong Panghanapbuhay sa Ating Displaced/Disadvantaged Workers Program or TUPAD is one of the flagship programs of DOLE which provides for an emergency employment program for those who work in the informal sector, underemployed, selfemployed, and displaced marginalized workers who have lost their livelihood or whose earnings were affected by COVID-19.



O: Who are the qualified beneficiaries under TUPAD?



Provided that they lost their livelihood or whose earnings were affected due to the Enhanced Community Quarantine against COVID-19.



O: Are workers in the informal sectors who live in regions which are not covered by the **Enhanced Community Quarantine (but have lost** their jobs or whose livelihood were affected by COVID-19) apply for the TUPAD program?

A: Yes, as long as they are considered as qualified beneficiaries under the program. (Official statement released by DOLE through publication in their website. See link: https://www.dole.gov.ph/covid-19-mitigating-measures/)



Q: Is there any limitation on the duration of work under the program?

A: Yes, the duration of work shall be limited to ten (10) days. Qualified beneficiaries are allowed to work for four (4) hours a day for ten (10) days. he program. (Official statement released by DOLE through publication in their website. See link:

Q: How will the TUPAD beneficiaries receive their salary?

A: It may be given directly by the DOLE or through money remittances.



Q: What is included in this assistance package?

Payment of wages equivalent to 100% of the prevailing highest minimum wage in the region;

Enrolment to group micro-insurance;

Basic orientation on Safety and Health thru dissemination of brochures

Be provided with cleaning solutions and properly advised to regularly and thoroughly wash their hands using soap and water or alcohol-based sanitizers

O: Does receiving financial support from the local government units (LGU) disqualify a person from the availing the TUPAD assistance?
